Product description

The Premier Elite IR is designed to detect movement of an intruder and activate an alarm control panel. The product is intended to be connected to a listed burglar compatible control unit or a power supply that has a voltage output range of between 9 to 15 VDC and provides a minimum of 4 hours of standby power.

1. Installation guidelines

The technology used in these detectors resists false alarm hazards. However, avoid potential causes of instability such as (see Fig. 1).

2. Opening the detector

- Unwind the screw at the base of the detector until loose; the screw will be retained in the product (see Fig. 2, step 1).
- Lift detector lid out from the base and off the lugs at the top (see Fig. 2, step 2).

3. Detector knockouts

4. Mounting the detector

5. Coverage & pick-up

6. Premier Elite IR set-up

- Set the mounting height by adjusting the position of the PCB.
- Wire the detector.
- Select the desired jumper settings.

7. Altering Coverage (at 2m Mounting height)

8. End of Line Jumper links

- The jumper links JP3 and JP4 are used to select resistances for End-of-Line (EOL) wiring applications.
- JP3: Selects the End-of-Line resistance. Equivalent to wiring a resistor of the selected value as shown.
- JP4: Selects the resistance across the alarm relay. Equivalent to wiring a resistor of the selected value as shown.
- If EOL wiring is not used, the headers should be left in the default (O/C) position.
- If the required resistance values are not available, leave the headers in the O/C position and wire in external resistors as normal.
